As a new customer to Lenox, we would like to first welcome you, and thank you for choosing Lenox as your new residence. We feel that all of our customers should have a guideline to help them better adapt to life in Lenox, so that is what we will discuss in this welcoming letter.

Garbage cans are emptied on Fridays, so please have your can out by the road by 7:00 a.m. Friday morning.

Utility bills are sent out for water, sewer and sanitation on the first of every month. If you do not receive a bill we strongly suggest that you contact City Hall to find out the amount of your bill before the 15th. Failure to receive a bill does not mean you do not owe a bill. If the bill is not paid by the 15th of each month a 10% penalty will be applied. If the bill is not paid by the 25th of each month, your services will be discontinued until all past due balances plus a \$30.00 reconnection fee are **paid in full**.

The City of Lenox does have a leash law, meaning that all dogs are to be on a leash, in an enclosed area or on a chain AT ALL TIMES. If we receive complaints about a dog, we will call the County Animal Control Unit and he will pick up the dog.
